



Application for Committee on Knowledge Extension Research (CKER) Actuarial Research Conference (ARC) Travel Grants

Return completed materials no later than **May 27, 2026**

The CKER is offering travel grants up to \$1,000 (U.S.) to graduate students pursuing a Ph.D. from the U.S., Canada or Mexico, who will be presenting at the 61st Actuarial Research Conference. The ARC will be held at **by The Ohio State University, July 21–24, 2026**. CKER will consider as many as two student applications per school, with the school advisor ranking the applicants when there are two from that school. The top-ranked applicant will be considered first; if there are any funds left after the initial funding decisions, CKER will consider the second student application. The grant amount, which covers transportation costs only, is based on the actual cost of **economy air travel and reasonable ground transportation**. If the applicant drives to the 59th ARC, a lesser amount will be awarded. Car rentals will be reimbursed **only** if authorized in advance. If mileage is reimbursed, gas and tolls will not be reimbursed. **Please note that there will be no reimbursement without receipts.** Each student will need an ARC presentation verification from an advisor, department chair or graduate program advisor (please see item #12). **Each student will also need to submit a 100-word abstract commenting on the purpose, background, data, methods, results and impact of the presentation.** Over time, candidates can receive no more than two grants, and only then if their presentations are on different topics. The two-time limit to receiving a grant is over the period the individual is enrolled in a Ph.D. program. The decisions of the CKER are final. Applicants will be notified if they will receive a grant by **June 11, 2026**.
